PROFILE

Ben Bittner is Managing Director of Acquisitions and Asset Management for SynerMark properties, Inc. Prior to joining SynerMark, Mr. Bittner spent thirteen years gaining experience in various aspects of the real estate industry. At Industrial Group Southwest (IGX), Ben Bittner was the Investment Officer.
